- (v) The firm should have experience in conducting Cost Audit of at least 2 PSU organization;
- (vi) The firm shall have at least 2 Partners having minimum 5 years' Cost Audit experience and also should have at least 2 (two) qualified Assistants (CWA) and 4 (four) Semi-qualified Assistants (Inter CWA).
- (vii)Subject to above criteria, preference shall be given to a firm having experience of conducting Cost Audit of company engaged in Engineering machinery (including Electrical & Electronic products/ Tea plantation products).
