This Corrigendum is issued with respect to the following clauses of the tender document:

4. Functionalities Required

(iv) Bidder will provide an operational guarantee of the designed website and provide free support & maintenance for at least 1 year after the launch of our website. All troubleshooting required would be the responsibility of the Bidder.

Clarification regarding the above point: The selected bidder is responsible for the proper working of the website during normal days and peak loads. He is also responsible for making changes in code level in case some updates are required in it. The selected bidder is not responsible for content creation and routine website updates.

(xviii) Design should allow changing the interface templates for a fresh new look as and when required.

Clarification regarding the above point: Since the above point is not relevant in the context of this Notice. This point may not be considered.

(xxviii) The bidder is also responsible for security audit of the website once the website is ready to be made live. The audited report should be submitted to the Institute after the completion of the security audit.

Clarification regarding the above point: The selected bidder will re-design & develop the website and once it is completed, he will suggest a few Govt. of India empanel agencies with us. Based on the inputs from the bidder, The Institute will conduct a security audit of the website.

The portal will be developed using the following technologies and the website will be hosted on separate applications and database servers. The downloadable content can be hosted on a separate file server in a reliable Meity empaneled CSP (Annexure IV)
