

<b>Invoice Validation Checklist under GST Law</b>	
<b>Checklist for E-INVOICE, Debit &amp; Credit Invoices</b>	
<b>1</b>	Invoice reference Number (IRN) and QR Code;
<b>2</b>	Name, address GSTIN, and State of the supplier;
<b>3</b>	The word "Tax Invoice" Or "Invoice" is must on Invoice
<b>4</b>	BIL No. / Challan No etc are not acceptable. Only the word "Invoice No." is acceptable
<b>5</b>	Consecutive serial number, in one or multiple series, containing alphabets or numerals maximum up to 16 digits for a financial year is acceptable.
<b>6</b>	"Date" of Invoice
<b>7</b>	Name, address, State and GSTIN of Recipient i.e. (DuPont, DSCI, Danisco, Pioneer) whatever is applicable must be mentioned on Invoice;
<b>8</b>	Product description with "HSN" code or Service description with Service Accounting Code "(SAC)" is must to be mentioned on invoice
<b>9</b>	Quantity, value and Tax Rate of goods. In case there are two or more line items on invoice with different tax rate, all line items are mention with HSN/SAC, Tax Rate and Tax Amount.
<b>10</b>	"Taxable value" of supply of goods or services and amount of discount if any;
<b>11</b>	"Total value" of supply of goods or services;
<b>12</b>	"Tax Rate" (central tax, State tax, integrated tax, Union territory tax or Cess);
<b>13</b>	"Amount of tax charged" in respect of taxable goods or services (central tax, State tax, integrated tax, Union territory tax or Cess);
<b>14</b>	Authorized/Digital signature should be there on invoice.
<b>15</b>	RCM Applicable Yes/NO
<b>16</b>	Place of supply along with the name of the State, in the case of a supply in the course of inter-State trade or commerce
<b>17</b>	For Supplies to DSCI, the invoice shall carry an endorsement "SUPPLY TO SEZ UNIT FOR AUTHORISED OPERATIONS UNDER BOND OR LETTER OF UNDERTAKING WITHOUT PAYMENT OF INTEGRATED TAX"

- a) E Invoice is mandatory for GST registered person whose aggregate turnover in a financial year exceeds INR 100 crore rupees.(W.e.F 1st Jan'2021)
- b) Excluded Category  
 SEZ Units  
 Insurance Company / Banking Company / Financial Institution  
 Goods transport Agency  
 Persons rendering Passenger transportation service
