### Roles & Responsibilities

Depending upon the team you join, the role and responsibilities may include

- Financial accounting and controlling tasks (daily PnL, month end close etc) with regards to the assigned areas within one of the teams mentioned above
- Prepare, analysis and review complex calculations, accounting journal entries, various reconciliations, management and external reporting as per defined book of work.
- Perform analytical review of P&L and BS movements by understanding the business drivers and accounting treatments
- Build subject matter expertise in the area of responsibility assigned to you
- Reviewing applicable policies periodically, assessing impact to process and implementing changes
- Execute appropriate controls in the processes, ensure risks and issues in processes are identified, reported, escalated and mitigated
- Respond to queries, ad-hoc requests and resolve issues from stakeholders and key business partners
- Have regular discussions with stakeholders to seek feedback, understand their needs and ensure we are meeting their expectations.
- Challenge current process and suggest process improvements to ensure process efficiency and effectiveness
- Prepare process documentation and keep them up-to-date
- Participate/lead business initiatives as required from time to time and ensure team is complying with the agreed requirements
- As a senior in the team, you may be required to ensure the team's deliverables are submitted timely and with good quality, motivate and inspire other team members and colleagues to improve performance, support the team lead to manage, deliver and comply with the requirements from senior management as and when requested.
